We will select acts to perform with the chance of winning the first prize of \$5,000, 2nd prize \$3,000, 3rd prize of \$1,000 or People’s Choice \$1,000.

- 1) Entry Forms must be received by 31st August 2020.
- 2) We will select finalists from all of the Acts who apply to perform live at the ‘Battle of the Sounds’. Notification of finalists will be after 7th September 2020.
- 3) The competition will take place on Saturday 14th November 10am – 3pm.
- 4) Each Act will perform for approximately 15 minutes on the main stage.
- 5) Acts may perform their own material or covers.
- 6) The Act finishing in first place will perform a song of their choice following the prize giving.
- 7) It is in your interests to encourage your fans to come along to the final to vote for you, so spread the word to your on-line following.

- There will be 1st, 2nd and 3rd place winning Acts and a separate People's Choice.
- 1st will receive \$5,000 in total for their Act, 2nd \$3,000, 3rd \$1,000 and People's Choice \$1,000.
- This competition is open to all ages.
- Contestants under the age of 18 may participate only with the consent of their parent or guardian who must give consent on the application form (see consent form attached).
- Contestants must be amateur singers, otherwise be a part-time singer in the entertainment industry.
- Contestants must not have an existing full-length album released.
- The Geraldine Festival Inc. has the right at any time to require proof of identity and/or eligibility. Failure to provide such proof in a reasonable amount of time could result in disqualification from the competition.
- The Geraldine Festival Inc. reserves the right to disqualify any contestant from the competition or auditioning process at its sole discretion, should the contestant at any stage supply untruthful, inaccurate or misleading personal details and/or information or should the contestant be ineligible for the competition pursuant to these rules.
- By submission of an application and entering into this competition, each contestant represents and warrants his or her compliance with these rules and regulations. No contestant will be permitted to perform unless he or she has acknowledged and agreed to these rules and regulations.
- By entering, each contestant agrees that The Geraldine Festival Inc. and their successors have the right to use their names, likenesses, and images of all persons performing for future advertising, promotion and publicity in any manner and in any medium now known or hereafter devised in perpetuity.
- The 'Battle of the Sounds' is a public event, so during your participation in the competition, any person or media or organisation, including The Geraldine Festival Inc., may be photographing or videotaping your image and/or audio recording your voice.
- No Death Metal. Songs containing vulgar or explicit sexual lyrics will not be allowed. Contestants who during their performance, use any obscene, offensive, sexual or otherwise inappropriate behavior or gestures, including without limitation those referencing or depicting violence, nudity or explicit activity - or which are not in the spirit of the contest will be disqualified from the competition.
- Participants will be responsible for the safekeeping and insurance of all props and instruments. The Geraldine Festival Inc. will not be liable for any claims, demands, actions, and causes of action whatsoever arising out of or related to any loss, damage, or injury.
- By participating in this contest, contestants agree to be bound by these rules and the decisions of the judges.
